- 1) THE VEHICLES MASS AND DIMENSION SHALL NOT EXCEED THE LIMITS PRESCRIBED UNDER SCHEDULE A OF NB REGULATION 2001-67 AND,
- 2) THE GROSS VEHICLE WEIGHT (GVW) SHALL NOT EXCEED THE GREATER OF: THE GVW LIMIT PRESCRIBED FOR THE HIGHWAY UNDER SCHEDULE B OF NB REGULATION 2001-67, OR THE APPROVED UPATED GVW LIMIT FOR THE HIGHWAY.
- 3) NO ADDITIONAL MASS SHALL BE GRANTED ON AXLE GROUPS OR GROSS VEHICLE MASS
- 4) ROUTES WHICH HAVE BEEN APPROVED UNDER THE UPRATING PROGRAM ARE POSTED, ON THE DEPARTMENT OF TRANSPORTATION AND INFRASTRUCTURE (DTI) UPRATING PROGRAM WEB PAGE, <http://www2.gnb.ca/content/gnb/en/departments/dti/trucking/hup.html>
- 5) THE UPATED GVW LIMIT OF A HIGHWAY IS RESTRICTED TO SPECIFIC DATES AS POSTED WITHIN THE APPROVED ROUTE LIST ON THE DTI UPRATING PROGRAM WEB PAGE.
- 6) VEHICLES OPERATING ON A ROUTE OUTSIDE OF THE TIME PERIOD SPECIFIED FOR THE UPRATING MUST NOT EXCEED THE MASS AND DIMENSION LIMITS PRESCRIBED IN NB REGULATION 2001-67
- 7) THE PUBLISHED ROUTE LIST IS SUBJECT TO CHANGE WITHOUT NOTICE. ALL POSTED CHANGES WILL BE EFFECTIVE AT 12:01 AM OF THE DATE INDICATED.
- 8) THE VEHICLE PERMIT IS NOT VALID DURING THE SPRING WEIGHT RESTRICTION PERIOD
- 9) THE VEHICLE PERMIT IS NOT VALID ON ANY ROUTE WHICH IS CLOSED TO TRUCKS
